

The York County Board of Commissioners met according to law for an emergency meeting on November 4, 2010 at 9:00 a.m. as per notice in the York News Times on November 3, 2010 and by posting notice in the City of York Library, York News Times, City of York office and on the bulletin board in the Courthouse lobby. Present were Chairman, Augustus M. Brown Jr., Patricia Bredenkamp and Eugene Bergen. Also present were Melanie Wilkinson, correspondent for the York News Times and Tom Shellington. Commissioners Steve Neujahr and Kurt Bulgrin were absent.

The agenda of the meeting was posted on the bulletin board in the County Clerk's office and a copy of the agenda was made available to each Commissioner.

Brown announced that the Open Meetings Law was posted outside the door along with copies in the back of the Board Room. Proof of publication was also available.
